FIRST WORKING **BEE FOR 2020**

10am at the Rotunda

WHAT IS THIS? "The Boundary Road Project" or is it the proposed destruction of 100ha of old growth forest.

Late last year you would have received notice about a general drop-in session providing information about what is called "The Boundary Road Project" and you may have attended such a session. Perhaps you didn't go thinking it had no relevance for you - Boundary Road being in Dromana/Arthurs Seat and away from the McCrae foreshore.

Then you may have also noticed that the quarry scar on Arthurs Seat has grown substantially in the last six months. All this activity points to one thing, the fact that Hillview Quarries wishes to open a

new quarry on Arthurs Seat which could be up to 4 times bigger than the current quarry operated by them. See the photograph above. Hillview has requested a pit of 107 acres 190 metres deep; and 38ha of forest cleared. Dr Mark Fancutt, President of the Peninsula Preservation Group Save Arthurs Seat spoke to members at the AGM in December and outlined what this new quarry will mean not only to the 10 endangered vegetation classes and over 24 endangered fauna species which will be destroyed in the process, but also the residents, schools and food producers of Dromana who will

President: Len Warfe 5987 2537 be subjected to blasting, noise, dust and around 40 truck trips per day.

Millions of dollars have been invested by Federal and State governments to establish a biolink across the Mornington Peninsula and Landcare groups are working hard to connect each of the conservation areas to protect the ecological significance of our parks and to eventually connect through from Greens Bush to Cape Schanck.

Recent reports from the Shire, government and the United Nations state that biodiversity is declining, the primary cause being land clearance. And the development of this new quarry which forms an essential component of the biolink, would lead to inevitable and wider-spread loss of biodiversity.

For what – to extract one million tonnes of rock per year for 70 years. This rock is unlikely to be used on the Mornington Peninsula as most major infrastructure projects and growth will be to the west of Melbourne and through the Cardinia, Berwick and Officer areas. There are much larger and more accessible reserves of granite in Gippsland which do not result in mass habitat loss which could be utilised.

The owner of Hillview Quarries is the RE Ross Trust - a charitable trust established in 1970 whose revenue is derived from Hillview Quarries in Dromana. Their mission is to:

- Address disadvantage and inequity;
- 2. Encourage and promote social inclusiveness, community connectedness, health and wellbeing;
- 3. Protect and preserve Australian flora and fauna.

The Trust has supported many worthy charities and organisations throughout Victoria. But this comes at great expense. The Ross Trust has pursued projects which would cause irrevocable environmental, economic and social damage to the Mornington Peninsula (which incidentally, receives only a tiny portion of annual donations).

Add your voice to the opposition of this quarry. – **Attend the community meeting being held by the Peninsula Preservation Group on Saturday 7th March 2020 at 4pm in the Dromana Community Hall.

Port Phillip Bay Fund Round 3 Community Grants

Work is well under way under this project which aims to reduce the cover of high-threat weed species in the McCrae and Rosebud Foreshore Reserves (from Chinaman's Creek to Anthonys Nose) in line with the Shire's natural systems strategic priorities. Carried out under the auspices of the Shire Bushland Management Team.

Port Phillip Westernport VLG Grant 2019/2020

We were successful in attracting a support grant of \$500 under this scheme. These monies will cover our insurance and compliance costs for 2020.

In addition:

The group made a submission to the Mornington Peninsula Shire to allocate funds in the 2021/2020 budget to further rejuvenate Eyrie Creek.

NEW BEACH FURNITURE

You may have noticed the two new picnic tables and several new seats which have been installed along the Bay Trail. The MHCG was very surprised to see these new additions, particularly as they had been erected in areas we are trying to revegetate, and were very disappointed that we had not been consulted – or even just plain informed, that this furniture was to be installed.

On enquiry, we were advised that the installations had been carried out by the Shire at the request of a local Probus walking group.

We sought a meeting with Shire Officers to discuss the matter. We're not particularly opposed to the installation of seating to ensure Bay Trail walkers have adequate places for rest but were concerned that the placement of the picnic tables was inappropriate. Shire Officers admitted the matter could have been handled better, and the end result of the discussions is an agreement that the seats remain but the picnic tables be removed. This was to have taken place before the end of 2019, but as of last week they were still there.
